UK exporters impeded by labour shortages

BCC, in partnership with DHL, latest Quarterly International Trade Outlook shows exporters are being hampered by widespread labour shortages, particularly in manufacturing, where two-thirds of firms struggled to recruit in the first quarter of 2018.

Number of EU workers leaving UK eases but industry still faces recruitment crunch EEF 21 May 2018

A new EEF report warns that nearly half of the UK's manufacturers remain concerned about their ability to access skills post-Brexit. The slump in job applications from the EU has slowed since last year, but 17% of companies saw a drop in applications from European citizens.



NIESR has revised lower its GDP forecast for 2018 to just under 1.5% mainly due to weak performance in the first quarter. But the slowdown is likely to be temporary. Inflation peaked in November 2017 and is forecast to ease back to the target rate of 2% over the next 8 quarters.
